The Tenth Judicial Circuit Pro Bono Committee will recognize National Pro Bono Week and celebrate attorneys who have provided pro bono legal services within the circuit at their Celebrate Pro Bono Reception on Monday, October 20 from 5:30 – 7:30 p.m. at the Caterpillar Visitors Center in Peoria. The event is open to attorneys, court staff, and to the press. Special guest speaker Illinois Supreme Court Justice Thomas Kilbride will deliver keynote remarks, and other speakers include Tenth Judicial Circuit Chief Judge Stephen A.
